**ORDER GRANTING IN PART AND DEFERRING IN PART DEFENDANT'S MOTION
TO DETERMINE CONFIDENTIALITY OF COURT RECORDS**

THIS CAUSE came before the Court without a hearing, on Defendant's Motion to Determine Confidentiality of Court Records, filed on December 18, 2025 [Docket No. 11]. The Court read the Motion, the Response in Opposition, filed on November 24, 2025 [Docket No. 10] and notes that a hearing was held on January 20, 2026, in related case number 2025-CA-654 on the same issues raised herein. Being duly informed, it is hereby

ORDERED AND ADJUDGED that:

1. Plaintiff, Trident Ventures Group, LLC, improperly filed a document with social security numbers in violation of Florida Rule of General Practice and Judicial Administration 2.420 and 2.425, on page 29 of the Verified Application for Court Ordered Inspection filed by Plaintiff Trident Ventures Group, LLC on September 10, 2025 (Docket No. 2).
2. The Court **GRANTS** the Motion to the extent it seeks to seal these pages.
3. The Clerk of Court or his designee is directed to immediately seal and treat as confidential the following page and to keep such page from public access:

(a) Page 29 of the Verified Application for Court Ordered Inspection filed by Plaintiff Trident Ventures Group, LLC on September 10, 2025 (Docket No. 2).

4. If Plaintiff Trident Ventures Group, LLC deems it appropriate, it may refile this page without social security numbers in conformity with the Florida Rules of General Practice and Judicial Administration and all other applicable Court rules or law.

5. The Court **DEFERS RULING** on the remainder of the Motion until an evidentiary hearing is held.

6. Counsel for the parties shall promptly confer and schedule an evidentiary hearing through JACS within thirty (30) days of this Order on the Court's hearing docket. The hearing does not need to be held within thirty (30) days but must be scheduled within thirty (30) days.

7. The Clerk is directed to publish this Order in accordance with Fla. R. Gen. Prac. & Jud. Admin. 2.420(e).
