

NOTICE OF UPCOMING DESTRUCTION OF SEALED CRIMINAL COURT CASES

It has been determined by the Clerk of the Circuit Court and Comptroller, Seminole County, ("Clerk's Office") that there exists sealed criminal court records that have met their retention period as provided in Florida Rule of General Practice and Judicial Administration 2.430 and are eligible for destruction.

The Clerk's Office is hereby giving notice of the below list of eligible case numbers and styles on the Clerk's Office's website (www.seminoleclerk.org) for a period of no less than 30 days.

Any person seeking to object to the destruction of any sealed criminal court record described in the below list must file such objection with the Clerk's Office in writing to clerk@seminoleclerk.org or Clerk's Administration, 91 Eslinger Way, Sanford, FL 32773. Any objections received by the Clerk's Office will be reviewed and filed.

Upon expiration of the 30-day posting period described above, the Clerk's Office will file an affidavit stating the listing of sealed criminal court records eligible for destruction has been publicly posted. If no objections are received, the Clerk's Office will state in the affidavit that no objections have been received.

If any objection is filed, the objection will be scheduled for hearing before the Chief Judge, or Chief Judge's designee. The Clerk's Office will notice the objecting party of the hearing on the objection. The Clerk's Office will also post a notice of hearing on the Clerk's website (www.seminoleclerk.org) for a period of no less than 10 days prior to the scheduled hearing date and time. Upon the expiration of the 10-day posting for the notice of hearing, the Clerk's Office will file an affidavit stating that notice of hearing has been publicly posted as described in this section.
