**ORDER ON DEFENDANT ORLANDO CAR DEALS' MOTION TO DETERMINE
CONFIDENTIALITY AND TO ENTER ORDER TO REDACT**

THIS CAUSE came before the Court on December 16, 2021, Defendant Cal-Tenn Financial, LLC d/b/a Orlando Car Deals' ("Orlando Car Deals") Motion to Determine Confidentiality and to Enter Order to Redact, and the Court having reviewed the Court file, and otherwise being fully advised of the premises:

It is ORDERED and ADJUDGED that:

1. Orlando Car Deals' Motion to Determine Confidentiality and to Enter Order to Redact is GRANTED.
2. The Court makes the following findings, pursuant to Fla. R. Jud. Admin. 2.420(e) (3):

- a. Type of case: civil proceeding.
- b. Grounds for confidentiality: Fla. R. Jud. Admin. 2.420(c)(7) and (c)(8), as well as Fla. R. Jud. Admin. 2.425(a)(3), (4), and (5).
- c. The names of the parties to this action are NOT confidential.
- d. The progress docket and similar records in this case are NOT confidential.
- e. The particular information that is to be redacted and permanently remain confidential is the following:

4. The Clerk is hereby directed to permanently redact all of information in the document identified in paragraph 2 above, so that it is not accessible to the public (including online, in-person, and in response to any requests).


5. The documents subject to this Order shall, however, be available to the Court, the parties, and the parties' counsel of record.
