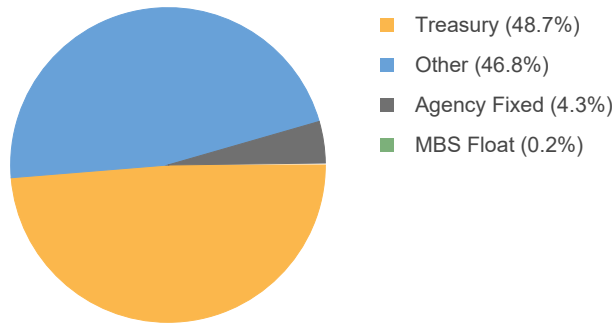

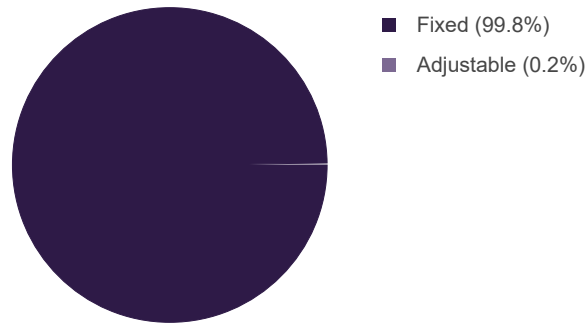

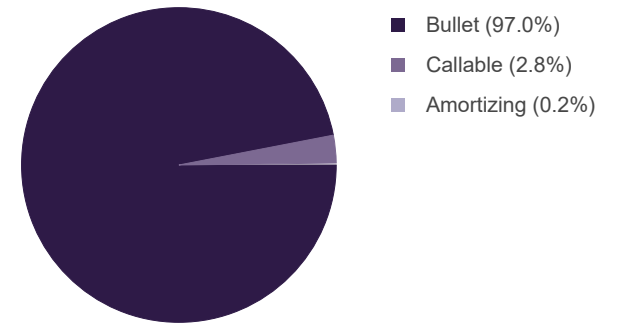
Sector Allocation
