**ORDER GRANTING IN PART AND DEFERRING IN PART PLAINTIFF'S AMENDED
MOTION TO DETERMINE CONFIDENTIALITY OF COURT RECORDS**

ORDERED AND ADJUDGED that:

1. Defendant, Maria I. Moller ("Moller"), improperly filed two documents with social security numbers in violation of Florida Rule of General Practice and Judicial Administration 2.420 and 2.425, on page 67 of the Notice of Related Proceedings filed September 17, 2025 (D.E. 34) and page 18 of the Notice of Filing filed October 9, 2025 (D.E. 46).

2. The Court **GRANTS** the Motion to the extent it seeks to seal these pages.

3. The Clerk of Court or his designee is directed to immediately seal and treat as confidential the following pages and to keep such pages from public access:

(a) Page 67 of the Notice of Related Proceedings filed on September 17, 2025, by Defendant Maria I. Moller (D.E. 34); and

(b) Page 18 of the Notice of Filing filed on October 9, 2025, by Defendant Maria I. Moller (D.E. 46).

4. If Defendant Maria I. Moller deems it appropriate, she may refile these pages without social security numbers in conformity with the Florida Rule of General Practice and Judicial Administration and all other applicable Court rules or law.

5. The Court **DEFERS RULING** on the remainder of the Motion until an evidentiary hearing is held.

6. Counsel for the parties shall promptly confer and schedule an evidentiary hearing through JACS within thirty (30) days of this Order on the Court's hearing docket. The hearing does not need to be held within thirty (30) days but must be scheduled within thirty (30) days.

7. The Clerk is directed to publish this Order in accordance with Fla. R. Gen. Prac. & Jud. Admin. 2.420(e)(45).
